

## **MORSTON PARISH COUNCIL**

### **MINUTES of the parish council meeting held on Wednesday, 27<sup>th</sup> June, 2018 at the Village Hall, Morston - 7.30pm.**

#### **1a. To receive and consider apologies**

Apologies were received and accepted from J.Temple, S.Bean, and Mrs.R.Hamond. Apologies were also received from V.Egan (NT) and PC.J.Pegden.

#### **1b. To receive Declarations of Interest on agenda items**

(f) NCC Highways Rangers visiting parishes (g) public rights of way/footpaths; reminder re additions or changes to the Definitive Map – deadline in 2026.

\*\*\* K.Ward (NNDC) reported on the following :- (a) NNDC now participating in social subscribing (funded by Government); assistance to people with health and social problems (b) NT planning application re the quay. (parish council supports this) (c) Appeal dismissed re PO/17/0645.

\*\*\* PC.J.Pegden reported via email on the following :- (a) no calls or recorded crimes since the last meeting (b) still having problems with maritime thefts along the coast.
